776 BC First records of Greek Olympics, though it is believed they had been going

on for at least two prior centuries, involving athletes who, by and large,

derived the means of their existence from their status as sportsmen.

Boxing added as Olympic sport. Most famous boxer of this era is

Melanomas of Karia, who believed injuring an opponent showed a lack of

bravery.

Romans invent the <u>caestus</u>, a boxing glove reinforced with iron and lead,

transforming the Greek art of boxing into a deadly spectator sport.



Roman Emperor Theodosius abolishes the Olympics in effort to abolish

pagan rituals.

10/8/1805 William Richmond of New York, the first African American boxer, fights

English champion Tom Cribb; the fight is billed as "Cribb and Richmond

(The Black)."


New York Knickerbockers become first organized baseball club.

7/9/1846 First baseball game between the New York Nine and the Knickerbockers

Club in Hoboken, New Jersey.

First Belmont Stakes won by Ruthless.

First professional baseball team, the Cincinnati Red Stockings.



Queensbury Rules of boxing adopted, requiring the boxers to wear gloves and allowing for a one-minute rest period between rounds.

First Preakness Stakes won by Survivor.

Coal baron William A. Hulbert founds the National League of Professional Baseball Clubs. To prevent players from freely moving to the club that offers them the most money, the teams secretly agree to reserve players at the end of each season.

First Wimbledon Tennis Championship.

Moses Fleetwood, a catcher for Toledo of the American Association, becomes first African American in professional baseball.

Providence defeats New York in first unofficial baseball World Series.

<u>James\_Naismith</u> invents the game of basketball at the International YMCA training school.



4/8/1893	First college basketball game between Geneva College and New Brighton YMCA in Beaver Falls, Pennsylvania.
1896	First modern Olympic games involving only men. Including women, the organizers said, would be "impractical, uninteresting, and unaesthetic."
1903	Jack Johnson defeats Ed Denver to win the Negro Heavyweight Crown; asked whether Johnson can get a shot at the crown, the World Champion Jim Jeffries declares, "I will not fight a negro."
10/1903	National League and American League agree to combine, holding first World Series.
1905	This year in college football sees 18 deaths and 149 serious injuries.
1906	NCAA born as the Intercollegiate Athletic Association: "Its object shall be regulation and supervision."
May 1908	At the first Kentucky Derby, 13 of the 14 jockeys are African American. By the mid 1920's, blacks would be excluded from riding in major races.
12/25/1908	Jack Johnson knocks out Canadian Tony Brown to become the first African American world boxing champion, winning \$30,000. Reportedly, no one in the crowd of 20,000 cheers.



8/19/1909

First race at Indianapolis Speedway resulting in the death of two drivers, two mechanics and two spectators.

7/4/1910

Jim Jeffries is persuaded out of retirement to become the Great White Hope. Johnson knocks him out in the 15th round, earning the then princely sum of \$110,600.

5/30/1911

First Indianapolis 500.

Summer 1912

Jim Thorpe wins gold medals in pentathlon and decathlon, only to have them taken away the following year because he had earned \$25 a week playing baseball in 1909.



1915

Paul Robeson of Rutgers and Fritz Pollard of Brown break the color barrier in college football.

1919

Eight members of the Chicago White Sox, including Shoeless Joe Jackson, are banned from baseball for accepting bribes to throw the World Series to the Cincinnati Reds.



2/14/1920

Rube Foster, the father of black baseball, organizes the Negro national



League.

9/17/1920

Fourteen professional football clubs agree to combine to form the American Professional Football Association, restricting player movement and abiding by a set of league rules.

9/1920

African American Fritz Pollard joins the Akron Pros and leads the team to a 15-0-4 record, becoming its player coach the following year.



Boston Red Sox sell Babe Ruth to the Yankees for \$125,000.



1921 APFA changes its name to the National Football League.

Federal Baseball Club of Baltimore v. National League of Professional Baseball Clubs, <u>259 U.S. 200</u>. Chief Justice Holmes rules that baseball is not subject to the antitrust laws because it is not part of interstate commerce.

Cumberland Posey forms the New York Renaissance, a barnstorming African American basketball team.



1923

Summer 1924

African American DeHart Hubbard allowed to compete in the "Chariots of Fire" Paris Olympics in the long jump where he wins the gold and is the first man of color to win a medal; though he was the fastest American, and probably the fastest human, he is held out of the 100 dash because it is the premier event of the games.



Fall 1924

First Negro World Series between Negro Eastern League and Negro National League.

Winter 1924

First Winter Olympics.

1925

International Olympic Committee defines "amateur" as "one who devotes himself to sport for sport's sake without deriving from it, directly or indirectly, the means of existence."

1925

<u>Harold Red\_Grange</u> stuns the sports world by leaving college after his sophomore year to join the Chicago Bears for a reported \$5,000. NFL thereafter adopts an eligibility rule prohibiting teams from signing players until they are at least four years removed from high school.



1927

Members of Chicago's Wendell Phillips High School call themselves the Savoy Big Five. With their agent Abe Saperstein, they become the Harlem Globetrotters.

1930

Babe Ruth offered a salary of \$80,000. Asked if he was overpaid because President Hoover had only earned \$75,000, Ruth reportedly replies, "I had a better year than he did."

1931

Basketball player George Gregory of Columbia University becomes the first African American named as an All American.

5/1933

Five drivers killed in Indianapolis 500.

1933 NFL teams agree to ban African Americans from the league.

The New York Renaissance Five, the Rens, an all black professional basketball team, are refused acceptance into the white professional league

but defeat the Boston Celtics in 7 of 8 challenge games.

1935 African American Hank Williams plays for the Buffalo Bisons in pro

basketball's Midwest Basketball Conference.


Hank Greenberg gets dispensation from Rabbi to play on Rosh Hashanah but is told he must sit out if a world series game falls on Yom Kippur.



1936 First NFL draft of college players.

Summer 1936

Jesse Owens wins four gold medals in Berlin Olympics staged by Adolph Hitler as a showcase of the Nazi regime. At the end of the games, Avery Brundage, chairman of the USOC and track coach Dean Cromwell, both Nazi sympathizers, remove Marty Glickman and Sam Stoller from the 4 x 100 relay so as to avoid further embarrassment for Hitler if two Jews were to win gold medals. Following the games, Brundage is elected to the



International Olympic Committee.

100,000 fans turn out to see exhibition game between the Negro League allstars and the Cleveland Indians.

1936

1937

Jockey Sammy Renick is injured while riding, leading to the formation of a jockeys' labor organization called the Jockeys' Guild.

6/29/1937

Joe Louis knocks out Jimmy Braddick to become heavyweight champion of the world.



6/22/1938

Joe Louis defeats German Max Schmeling in 124 seconds before 70,000 fans at Yankee Stadium.

7/4/1939

Lou Gehrig speaks to a crowd of 60,000 at Yankee Stadium: "For the past two weeks, I've been reading about my bad break. Today I consider myself the luckiest man on the face of the earth."

1940

The Harlem Globetrotters defeat the Chicago Bruins of the NBL to win the Chicago World Professional Basketball Tournament.

1/17/1942

Cassius Marcellis Clay, Jr. born in Louisville, Kentucky.

1942

Bill Jones and three other African Americans join the Toledo Jim White Chevrolets in the National Basketball League which becomes the first integrated professional sports league.

1942	On the subject of whether to suspend baseball during the war. President
	Franklin D. Roosevelt declares, "I honestly feel it would be best for the
	country to keep baseball going."

1943 Frank Whitaker of the University of Chicago becomes the first African American to play in the Big 10 Basketball Conference.

Fifteen year old Joe Henry Nuxhall plays in his first major league game, pitching for the Cincinnati Reds.

NBA, known as the Basketball Association of America, founded.

1946 Kenny Washington of the Los Angeles Rams becomes the first African American to play in the NFL since the 1933 ban.

4/10/1947 Jackie Robinson joins the Brooklyn Dodgers.

Larry Doby joins the Cleveland Indians, becoming the first African American in the American League.



8/26/1947

Dan Bankhead of Brooklyn is first African American to pitch in a league game and hits a homerun in his first at bat.



8/13/1948

Satchel Paige of Cleveland debuts as first African American to pitch in the American League and shuts out Chicago.



1949

Gardella v. Chandler, 172 F.2d 402 (2d Cir.). Danny Gardella is successful in antitrust challenge to baseball owners' agreement not to accept his return from a jump to the Mexican League. Branch Rickey claims Gardella's attempt at free labor possesses a "communist tendency."

1950

Three African Americans are the first to be selected in the NBA draft including Earl Lloyd who becomes the first to play in an NBA game.

1950

Althea Gibson becomes first African American to compete in United States National Tennis Championships at Forest Lawn.



1951

Althea Gibson becomes first person of color to compete at Wimbledon.

3/1952	Solly Walker becomes the first African American to play in University of Kentucky arena, later named for its coach Adolph Rupp, when St. Johns defeats Kentucky in the NCAA East Regional.
3/1952	Tennessee State becomes the first black college invited to the NAIA (later the NCAA) Basketball Tournament.
Summer 1952	Russia participates in Olympics for first time in 50 years, winning 71 medals. The Soviets will thereafter dominate the games with athletes whose means of existence are derived from their role as sportsmen.
1953	Schentzel v Philadelphia National League Club, 173 Pa. Super. 179. Fan injured by foul ball at Shibe Park fails in claim for damages.
1953	Sir Edmund Hillary succeeds in climb of Everest along with native Sherpas who also carry the equipment.
1953	Toolson v. New York Yankees, <u>346 U.S. 356</u> . George Toolson is unsuccessful in antitrust challenge to baseball's reserve clause because baseball does not constitute interstate commerce.



Charles Dumas becomes first human being to jump 7 feet at high jump Olympic trials.



1956

Paul Hornung, the Golden Boy of the 2 and 8 Notre Dame Fighting Irish, wins the Heisman while Jim Brown, the greatest college football player of that or any year, comes in fifth. Brown had run for 986 yards and fourteen touchdowns in the 8 games Syracuse played that season. (He scored 43 goals in the 10 lacrosse games played.)



National Football League Players Association ("NFLPA") formed.

1957 Radovich v. NFL, 352 U.S. 445. Supreme Court rules NFL does not have

baseball's antitrust immunity.

1958 Brooklyn Dodgers move to Los Angeles.

1958 Willie O'Ree of the Boston Bruins becomes the first African American to

play in the NHL.

May 1958 Wilt\_Chamberlain turns pro after his junior year at the University of

Kansas, joining the Harlem Globetrotters.

1959 Pumpsie Green joins the Red Sox, the last baseball team to integrate its

roster.




Summer 1960 18 year old Cassius Clay wins gold medal in Rome Olympics. After

returning to Louisville to find he is still subject to racism when refused

service in a local diner, he tosses his gold medal into the Ohio River.

Birth of the American Football league, a rival to the NFL.

3/2/1962 Wilt Chamberlain scores 100 points in game against the New York Knicks.



5/29/1962

Buck O'Neill of the Cubs becomes first African American to coach in major league baseball.

1962

Emile Griffith knocks out and kills Benny "The Kid" Parret in a nationally televised bout.



1963

Featherweight Davey Moore dies after being pounded in a nationally televised fight against Sugar Ramos: "I hit him, yes, it's true. But that's what I'm paid to do. Don't say murder. Don't say kill. It was destiny. It was God's will."




11/24/1963

Two days after Kennedy assassination, NFL decides games will be played.



2/25/1964

Cassius Clay defeats Sonny Liston after 6 rounds to become heavyweight champion of the world. After the fight, he announces he is a Black Muslim and has changed his name to Muhammad Ali.

1964

After a goal is disallowed in Olympic qualifying soccer match between Argentina and Peru, fans riot, leaving 309 people dead and 1000 injured.

10/6/1965

Sandy Koufax refuses to pitch the first game of the World Series because it falls on Yom Kippur. When Don Drysdale gets hammered during the first game and manager Alston comes out to get the ball, Drysdale says, "Skip, I bet you wish I was Jewish today, too."

1966

At the peak of his career and after only nine seasons, Jim Brown announces his retirement from football to devote more time to his movie career and to race relations.



3/19/1966

Texas Western College, now known as UTEP, wins national collegiate basketball championship, beating Kentucky easily 72-65 with five black starters against all white Kentucky squad coached by Adolph Rupp.

1966

Bill Russell of the Boston Celtics becomes the first African American to coach a professional sports team.



1966

NFL agrees to merge with the AFL so it may monopolize the game.

1967

Birth of the American Basketball Association, rival to the NBA.

1/15/1967

Green Bay defeats Kansas City 35-10 in the first Super Bowl.



April 1967

Muhammad Ali refuses induction into the Army claiming conscientious objector status and stating "No Viet Cong ever called me nigger." The World Boxing Association strips him of his title and of his license to box.



5/27/1967

Middleweight boxer Rubin Hurricane Carter is convicted by an all white jury in Patterson, New Jersey <u>for somethin' that he never done."</u>



7/20/1968

First Special Olympics held at Soldier Field in Chicago.

Summer 1968

At Mexico Olympic games, Bob Beamon shatters the long jump record by 21 inches and Dick Fosbury debuts the flop to win the high jump. At the ceremony for the 200 meters, Tommie Smith and John Carlos raise a black gloved fist during the playing of the Star Spangled Banner. The two are suspended from further participation and deported.







10/15/1967

Jim Hines becomes first human being to run 100 yards in less than 10 seconds.



NFLPA and NFL enter into their first Collective Bargaining Agreement.

1/16/1970

Curt Flood of the Saint Louis Cardinals files suit against major league baseball in federal court in Manhattan challenging the reserve clause as anticompetitive and a violation of the 13th Amendment prohibiting slavery. Flood plays for an openly racist manager and complains when he does not receive a raise while one is given to an inferior white player. At the trial, District Judge Irving Cooper taunts Flood in what union representative Marvin Miller characterized as racist treatment, asking, "This isn't as easy as playing centerfield, is it?" Ignoring Jackie Robinson's stirring testimony on behalf of Flood, Cooper rules in favor of the owners because "baseball has been the national pastime for over one hundred years and enjoys a unique place in our American Heritage." Flood never plays another inning.



11/1970

New Orleans Saints kicker <u>Tom Dempsey</u>, born with half a right foot and no right hand, breaks an NFL record by kicking a sixty-three yard field goal to lift the Saints to a last-second 17-16 victory over the Detroit Lions at Tulane Stadium.



1971

Denver Rockets v. All-Pro Management, Inc., 325 F. Supp. 1049 (C.D.Cal.), aff'd, 401 U.S. 1204. Spencer Heywood is successful in his antitrust challenge to NBA draft eligibility rule requiring player be four years removed from high school graduation class.



6/28/1971


United States Supreme Court reverses conviction of Muhammad Ali. *Clay, aka Ali v. United States*, 403 U.S. 698.

9/1971

Junior College transfer John Mitchell becomes the first African American to play football at the University of Alabama or for Paul Bear Bryant who after 35 years is the premier coach in NCAA football.

1972

Wayne Embry of the Milwaukee Bucks becomes the first African American General Manager in professional sports.



**Summer 1972** 

Black September terrorists kidnap 11 Israeli athletes, all of whom are killed either by the terrorists or in the rescue attempt. IOC President Avery Brundage, elected to the Committee 36 years before at the Berlin games,

orders that the games continue; one columnist writes, "It's almost like having a dance at Dachau." The United States basketball team then loses to the Soviet Union in the championship game and refuses the silver medal because of outrage over an official's decision. At the close of the ceremonies, Brundage does not mention the fallen athletes, outraging the Israelis.



1972 Philadelphia World Hockey v. Philadelphia Hockey, 351 F. Supp. 462 (E.D.Pa.). Players are successful in antirust challenge to limit on player movement because no serious arms length bargaining over rules.

> Flood v. Kuhn, 407 U.S. 258. Citing, among other things, "Casey At The Bat," Justice Blackmun rules that baseball is exempt from the antitrust laws.

> Blalock v. LPGA, 359 F. Supp. 1260 (N.D.Ga.). Ladies Professional golfer is successful in striking down as anticompetitive LPGA exclusion from market of golfer accused of violating certain rules.

> Three drivers and a crewman are killed, and 13 spectators injured, at the Indianapolis 500.

Word "amateurism" is removed from Olympic charter.

Kapp v. NFL, 390 F. Supp. 73 (D.Cal.), aff'd, 586 F.2d 644 (9th Cir. 1978), cert. den. 441 U.S. 907 (1979). Joe Kapp is successful in striking down as anticompetitive NFL Draft Rule, Tampering Rule, One Man Rule, Ransom Rule and Standard Contract Rule.

Frank Robinson becomes first African American manager in major league baseball.

Former NFL running back David Kopay, who hid his homosexuality throughout his ten-year playing career, publicly acknowledges that he is gay, becoming the first major athlete in history to do so. Former New York Giants offensive guard Roy Simmons later reveals his sexual orientation on The Phil Donahue Show.

1975

Robertson v. NBA, 389 F. Supp 867 (S.D.N.Y.). NBA players are successful in antitrust challenge to draft, reserve clause and merger if not subject of serious actual bargaining).

1975

*Bowman v NFL*, 402 F. Supp. 754 (D.Minn. 1975). Court strikes down as anticompetitive NFL concerted refusal to deal with former WFL Players.

1975

In Re Arbitration of Messersmith and McNally. Andy Messersmith and Dave McNally declared free agents by Arbitrator Peter Seitz who strikes down baseball's reserve clause; Curt Flood is already out of baseball.

1976

*Mackey v. NFL*, 543 F.2d 606 (8th Cir. 1976). John Mackey is successful in antitrust challenge to reserve clause in NFL because not bargained over.

12/9/1977

Kermit Washington punches Rudy Tomjonavich during Lakers Rockets basketball game, nearly killing him. Tomjonavich later sues the Lakers for failing to curb Washington's temper and is awarded a judgment of \$3,246,377.



1977

Bill Lucas becomes first African American General Manager in major league baseball.

1977

*Linseman v. WHA*, 439 F. Supp. 1315 (D.Conn.). Court strikes down as anticompetitive league rule declaring players younger than twenty years old not eligible for WHA draft.

1977

Remaining ABA franchises merge into the NBA.

7/13/1978

Ron Turcotte, who rode Secretariat to the Triple Crown, is paralyzed after a spill at Belmont Park, the site of his greatest triumph.



8/12/1978

Oakland Raiders cornerback Jack Tatum hits Pittsburgh Steelers wide receiver Darryl Stingley during an exhibition game, leaving Stingley paralyzed. After the game, Steelers head coach Chuck Noll decries the "criminal element in the NFL."



1978

Smith v. Pro-Football, Inc., 593 F.2d 1173 (D.C.Cir.). Yahoo Smith is successful in antitrust challenge to draft because not yet in collective bargaining agreement.

1979 Chuy v Philadelphia Eagles, 595 F.2d 1265 (3d Cir.). Eagle player fails in

defamation suit against club for releasing false information about why

player was forced to retire.

1979 Bayless v Philadelphia League Club, 472 F. Supp. 625 (E.D.Pa.). Injured

Phillie successful in asserting he is covered by Workman's Compensation

Act even though "a high priced athlete."

1979 *McCourt v. NHL*, 600 F.2d 1193 (6th Cir.). Hockey players fail in antitrust

challenge to reserve system in NHL because subject of collective

bargaining.

Willie Jeffries is hired at Wichita State University, the first black football

coach in Division 1A NCAA history.



Art Shell becomes the first African American to coach an NFL team since Fritz Pollard in 1921.





Federal Judge Lee Sarokin overturns Hurricane Carter's conviction and he is set free after serving eighteen years in prison. *Carter v. Rafferty*, 621 F.Supp. 533 (D.N.J.)

7/29/1986 Jury finds in favor of USFL against the NFL and awards damages of \$1.

The attorneys receive an award of \$20 million in fees.

11/22/1986 Mike Tyson knocks out Trevor Berbick in the 2d round to become the

youngest Heavyweight Champion of the World.



2/25/1987

Southern Methodist University receives the Death Penalty from the NCAA suspending its football program for two years because thirteen players had received payments totaling \$47,000. The program had generated \$4 million in revenues the previous academic year.

4/10/1987

Dodger General Manager Al Campanis tells Ted Koppel on the 40th anniversary of Jackie Robinson's debut on the subject of the lack of African Americans in the baseball's front office, "They may not have some of the necessities to be, let's say, a field manager, or perhaps a general manager . . . I don't say that all of them, but they certainly are short. How many quarterbacks do you have? How many pitchers do you have that are black?"

1987

*Wood v NBA*, 809 F.2d 954 (2d Cir.). Drafted college player Leon Wood fails in his antitrust challenge to salary cap and draft.

1987

Williams v NBA, 45 F.3d 684 (2d Cir.). NBA players fail in antitrust challenge to draft and salary cap because these are mandatory subjects of collective bargaining.

5/30/1987



At Summer Olympics in Atlanta, Eric Rudolph sets off bomb killing one and injuring others. Rudolph would later be convicted of also bombing an abortion clinic and a gay nightclub. Rudolph said the bombings were motivated by "a hatred of abortion and of a federal government that lets it continue."

Eighteen years and 53 days old Jermaine O'Neal of the Portland Trailblazers becomes the youngest player to ever play in an NBA game.

Antonio Alfonseca, who was born with six fingers, is signed to a contract by the Marlins. Alfonseca leads the major leagues with 45 saves in 2000.

Freeman later is forced to resign from the Times for falsifying his own resume. The article spurs an NCAA investigation into Clarett which concludes with no finding of academic wrongdoing but punishes Clarett for not being candid with NCAA investigators by suspending him for his sophomore season.

8/1/2003

Mike Tyson files for bankruptcy after a career in which he earned more than \$200 million.

8/2003

Always vigilant NCAA sanctions Utah basketball coach Rich Majerus for buying Keith Van Horn a meal while breaking the news that the player's father had passed away.

9/23/2003

<u>Maurice Clarett sues the NFL</u>, alleging that the NFL's age eligibility rule violates the antitrust laws.

12/2003

Sylvester Croom is hired as coach of Mississippi state, the first African American to coach a division 1A school in the South.

2/5/2004

Clarett v NFL, 306 F. Supp. 411 (S.D.N.Y.). After more than four months of extensive briefing, trial judge Shira Scheindlin finds the NFL eligibility rule to be in violation of the antitrust laws and orders Clarett eligible for the upcoming draft.

4/19/2004

The Second Circuit stays Judge Scheindlin's thoughtful decision after a nearly one-hour oral argument in which the three judge panel pound Clarett's counsel.

5/5/2004

14 year old Freddy Adu plays in his first professional soccer game.

5/24/2004

Clarett v. NFL, 369 F.3d 124 (2d Cir.). The Second Circuit reverses Judge Schindlin, holding the NFL's eligibility rule is shielded from antitrust scrutiny by the labor exemption because, among other things, the rule which had predated the union by fifty years and was not in the CBA was the result of collective bargaining.

7/20/2004

Jockey Gary Birzer is paralyzed when he is thrown from his horse at Mountaineer Race Track in Chester, West Virginia. After racking up over \$600,000.00 in medical bills, he and the world find out that the Jockeys' Guild allowed its catastrophic insurance policy to lapse, leaving him without coverage. Jockeys at tracks nationwide sign a petition calling for an audit of the Guild's books. Jockeys Guild Vice President Albert Fiss tells Birzer's wife that the Guild is using Berzer as a "guinea pig" to get racetracks to pay for on-track insurance.

At the start of ABC's Monday Football, blond Nicole Sheridan attempts to seduce Eagle wide receiver Terrell Owens in a skit which draws howls of outrage from conservative watchdog groups.



12/2004

Notre Dame fires Tyrell Willingham, leaving two black coaches in the 117 Division 1A schools, though Willingham is almost immediately hired by the University of Washington.

2005

NBA announces players may not join a team until they are one year removed from their high school graduation.
